**TerraGrid RX1300** is an integrally formed biaxial geogrid composed of quality polypropylene and carbon black with no inclusion of post-consumer recycled resin. The punched and drawn (stretched) manufacturing process for **TerraGrid RX1300** produces the following interrelated characteristics.
